During enumeration in the villages (58) ^{house} sites and (306) pucca houses are required to be provided to the above Chenchus. The proposals for pucca houses are being submitted to the Revenue Divil. Officer, Nagarkanoor for sanction of pucca houses.

The suitable land for providing house sites to house less (58) chenchu families is being selected. No sooner the land is selected, the L.A. proposals will be submitted to the Land Acquisition Officer (Revenue Divl. Officer Nagarkurnool) for acquisition of land.

The proposals in the prescribed forms are being submitted to the Revenue Divl. Officer, Nagarkurnool for sanction of Social Welfare Pensions in respect of the above eligible Chenchus as a special case.

ISSUE OF RATION CARDS:

All together (245) eligible chenchu families were issued white ration cards and no chenchu is left without ration cards except Jangireddipally H/o Amrabad village where about (2) white ration cards are required with a quota of 4.00 Quintals of Rice and 20 lbs of Sugar and (60) ltrs of Kerosine.

I have conducted a descrete enquirey in the villages and pentas about the working of chenchus as Agril labour in their own fields which are now under the occupation of land lords. During my enquirey in the villages it is revealed that there are no such cases. The lands which all under the possession of chenchus are being enjoyed by them selves. The chenchus are not working as Agril labourers any where.

The every steps are being taken to protect the rights of the chenchus and their lands. The possession of the lands which are under the occupation of the other than chenchus will be restored to original chenchus or their L.H.C no sooner the ejectment orders are received from the Revenue Divl. Officer, under L.T.R. Act.
